



From the committee's perspective there were two good outcomes of the November general election. Locally, the Wild Spaces Public Places halfcent sales tax passed easily; funds generated from this tax will be used to purchase land for conservation and for improvements to county public parks.

While the local League did not formally endorse this initiative, it was found recently that a similar initiative, passed in 2008, was supported by the League. Amendment 1 to the state constitution was crafted by a consortium of public utilities corporations and, if passed, would have prevented third party providers of solar energy. The public saw through the tricky language and voted it down. Wes Wheeler will have a detailed report in the next Voter on our League's participation in the state League's solar co-op program.

At the committee's November meeting, Chris Bird and Gus Olmos of the county Environmental Protection Department (EDP) presented the updated Stormwater Management Plan. Commissioner Mike Byerly was present and led the discussion. Currently the state deals with impaired, i.e., polluted, stormwater after the fact. In other words, if water is polluted, it by law must be cleaned, costing the taxpayer more than if had been protected initially. Over time stormwater quantities have increased due to growth, i.e., removal of natural absorbents.

In 2000, county residents overwhelmingly supported an amendment to the County Charter requiring improved standards for air and water quality. The local League approved of this amendment. However, the county has to date never acted on establishing regulations in accordance with citizen wishes, even though it has the legal authority to do so.

With growth continuing at a spiraling rate, it is time that the stormwater management plan is updated with more stringent regulations regarding water quality. The EPD is presently working on a plan, and a cost analysis, to establish reasonable requirements that hold developers accountable to control upstream pollution. The county's goal is to establish a baseline, which at a minimum must be met by it and the nine municipalities. The mantra is, or should be, we need to do something now to save future clean up costs.

But there is push back from the Chamber of Commerce, developers, real estate people, and the nine municipalities and their staff. And there are always those questions: how much should developers pay and how much should local governments (i.e., taxpayers) pay? And in all of this the public's interests are not well represented, i.e., the

public needs to be involved because in the end it is the public which pays through increased taxes. The bottom line is that water knows no boundaries. We are all in this together.

The committee discussed our approach. We all agreed that we would like Board approval to support the county's initiative to implement the tenets of the 2000 Charter Amendment. It was decided that our approach would be that good quality water (and air) are a policy, as set by the 2000 referendum, and that both the county and the municipalities should be in line regarding compliance with a set of uniform standards.

A workshop will be held in December to address developer concerns. This will be followed by public hearings in January with a potential vote by the County Commission in February.

The next meeting of the committee will be Wednesday, December 7 at 5:30 pm in the CIED building.


